## The Acacia Association Board of Director's Meeting

June 9, 2015

The Board of Director's Meeting of June 9, 2015 was called to order by Pres. O'Connor at 7:00 p.m.

Dirs. In attendance were: Pres. O'Connor, V.P. Eckert, Sec'y Brandush, Treas. John Polacek, King, Shepley, Murray, Bersin, and Kwiatek.

The Pledge of Allegiance was recited.

Motion (Brandush, Eckert) to approve the Minutes of the May 12, 2015 Meeting Minutes. Motion passed. (9/0/0).

**Treasurer's Report:** John Polacek reported that on the Treasurer's Report page we see that the assessment collection was \$74,920 with other sources giving a total income of \$75,513. Expenses were \$95,579 leaving the Net Ordinary Income of -\$20,065 which is normal for this time of year. The only unusual expense was the painting of the exterior of the Clubhouse. We will see deficit spending the rest of the summer and early Fall as we paint, fix driveways, landscape and enjoy the pool. The picture is normal for this time of year.

The Past Due Accounts showed an increase of about \$30. Six accounts were 76.8% of the total due. Those 6 accounts increased the accounts receivable by \$162. The rest of the accounts receivable had a reduced amount of \$142. We are handling all past due accounts in our normal fashion. We are in good financial shape.

Motion (Polacek, Kwiatek) to accept the Treasurer's Report as prepared by staff. Motion passed. (9/0/0).

Clubhouse Director's Report: Loretta Murray said that the Four Season Room is available for party rentals through the clubhouse and/or pool rentals. When there are not pool parties the residents are allowed to use the room, however, the bathroom in the Four Seasons Room is available to seniors and people with disabilities. We ask that the other residents and children continue to use the washroom in the locker rooms facility downstairs.
