3. When painting or maintenance is done to a townhome unit with a satellite dish/antenna, it will be the homeowner's responsibility to have the satellite dish taken down, replaced and/or re-aligned.
4. Acacia workers will not remove or replace.
5. **MUST BE NO LARGER THAN THIRTY-NINE (39) INCHES IN DIAMETER.**
6. Clothesline style antennas will not be approved.
