## The Acacia Association Board of Directors Meeting December 10, 2019

The Board of Directors Meeting of Tuesday, December 10, 2019 was brought to order at 7:00 p.m. by President Eckert.

Directors in attendance were: Pres. Eckert, V.P. Kalinoski, Sec'y Brandush, Tres. Polacek, Kwiatek, Murray, Boyd and Voyles.

The Pledge of Allegiance was recited.

Motion (Kwiatek, Boyd) to approve the minutes of the November 12, 2019 Board of Directors Meeting. All in favor. Motion passed. (8/0/0).

**Home Owners comments/questions:** No comments.

**Treasurer's Report:** John Polacek reports on the Treasurer's Report Page, we see that the Assessment Collection was \$85,957 with other sources giving a total income of \$87,148. Expenses were \$65,524 leaving a net ordinary income of \$21,606. We are starting to see the net for the month building the fund balances for next year.

The accounts receivable currently stands at \$3,262.21. 17 members have Past Due Accounts. We continue to do all the law allows to collect the outstanding balances.

We had 14 members miss their assessment payment. This cost each of them an extra fee and/or interest. Currently 226 members use the **ACH**, automatic bank withdrawal and 161 do not. **ACH** insures no late payment fee and no interest charge. **ACH** also saves the office time and money. Please consider this. 58.4% of Acacia Homeowners use it. Join the crowd! There really are no dangers. Acacia withdraws only the Assessment. If there are other charges, you receive a separate bill. When members do not pay on time, there is a cost of collection and a fee is charged. Avoid those charges with **ACH**. Overall, we are in good financial condition.

There has been a request for information about our Fund Balances. We have two funds – Reserve fund Balance and Operating Fund Balance. These will decrease for the next month as the crew and contractors finish their stuff at Acacia. We will then start building the balances for next year.

They now stand at: Reserve Fund Balance \$221,853.00

Operating Fund Balance\$551,713.73

Total \$773,566.73

Motion (Polacek, Kwiatek) to approve the Treasurer's Report. Motion passed (8/0/0).

Motion (Polacek, Murray) to increase assessment \$5.00 for 2020. Motion Failed. (5/3/0)

Motion (Polacek, Eckert) to adopt the 2020 budget. (8/0/0)

**Clubhouse Director's Report:** Loretta Murray reports that visit with Santa is Sunday, December 15<sup>th</sup> at the Acacia Clubhouse. Doors open at 11am, Santa arrives at noon.

Effective January 1, 2020 there will be a new Clubhouse rental agreement.

#### 2020 agreement:

200.00 Rental cost 50.00 deposit 150.00 balance due 2wks prior to party

#### Cost Breakdown

200.00 Rental cost

30.00 REFUND to residents (due 2 wks after party)

170.00 Pays attendant and association overhead cost

**Recreation Facilities Director's Report**: Amy Eckert reports that we received the 2020 pool contract from Chicagoland Pool Management. The cost is about 4% more than last year - but the pool will be open for 1 week longer and minimum wage is again increasing by \$1.00 per hour this year.

Motion (Amy, John) to accept the contract from Chicagoland Pool Management in the amount of \$46,987.00 for the 2020 pool season. Motion passed. (8/0/0).

**Grounds Maintenance Director's Report**: Jack Brandush wants to remind you to check the website acacia-ihp.org when it snows so you can see the snow plow route. It takes between 6-8 hours to plow all driveways. Thank you for your patience.

**Townhome Maintenance Director's Report:** Peggy Rose Kwiatek reports that 2 service requests were completed this past month. No new service requests for townhome maintenance will be accepted until April.

All crew members have gone home for the season. Jose remains on staff for the entire year.
